IN THE COUNTY COMMISSION OF SUMMERS COUNTY, WV

The County Commission of Summers County, sitting in regular session this 8th day of December, 2021, does hereby ADOPT the following redistricting plan:

New River Magisterial District shall include the following precincts: Precinct Numbers 4, 4A, 15, 17, 31 and 32.

Bluestone River Magisterial District shall include the following precincts: Precinct Numbers 9, 22, 23, 27, and 28.

Greenbrier River Magisterial District shall include the following precincts: Precinct Numbers 1, 11, 12, and 30.

Summers County shall consist of three Executive Committee Districts (which shall elect two males and two females from each district in accordance with W.Va. Code § 3-1-9(c)). The Executive Committee Districts shall be the same as the Magisterial Districts (comprised of the same precincts).

It is further ORDERED that the new polling place location for Precinct 32 and 31 will be located with Precinct 30 in the Talcott Elementary School. Precinct 26 has been merged into Precinct 23 and Precinct 23 and Precinct 22 will vote at the Jumping Branch Elementary School. Precinct 13 has been merged into Precincts 32 and Precinct 1 and those polling locations will be Precinct 32 at the Talcott Elementary School and Precinct 1 at the Forest Hill Volunteer Fire Department. Designated parts of Precinct 12 were merged into Precinct 32 and Precinct 4A. Precinct 32 will vote at the Talcott Elementary School and Precinct 4A will vote at the Hinton City Garage. A designated part of Precinct 27 has been split to form a new precinct, Precinct 28. Both Precinct 27 and 28 will vote at the Pipestem Volunteer Fire Department. Designated parts of Precinct 30 and Precinct 32 have been changed, both will vote at the Talcott Elementary School. All of these changes were due to the House of Delegates Redistricting.

These changes are being made due to polling place availability and the shift in population in accordance with the most recent Census. This will be a permanent change effective with the entry of this Order.

This ORDER changes the names and locations of Precincts within the county as follows:

Precinct 23 White Oak	Voting at Jumping Branch Elementary School
Precinct 27 Pipestem	Voting at Pipestem Volunteer Fire Department
Precinct 28 Indian Ridge	Voting at Pipestem Volunteer Fire Department
Precinct 30 Talcott	Voting at Talcott Elementary School
Precinct 31 Lowell	Voting at Talcott Elementary School
Precinct 32 Pence Springs	Voting at Talcott Elementary School

Following the State of West Virginia Redistricting process, Summers County is in First Congressional District, Tenth Senatorial District, 40th and 41st House of Delegate Districts.

Precincts in the 40th Delegate District are as follows: Precinct 1, 4, 4A, 9, 11, 28, 30 and 31. Precincts in the 41st Delegate District are as follows: Precinct 12, 15 17, 22, 23, 27 and 32.
