NOTICE OF AN OPPORTUNITY FOR PUBLIC MEETING AND COMMENT ON THE PROPOSED ABANDONMENT IN ITS ENTIRETY OF COUNTY ROUTE 3/42 (0.12 MILE) LOCATED IN SUMMERS COUNTY, WEST VIRGINIA

The West Virginia Division of Highways hereby provides notice of the proposed abandonment in its entirety of County Route 3/42, beginning at a point on WV 3, said point being 0.017 mile south of the junction of CR 3/44 and WV 3; thence northerly 0.12 mile and ending at the northern abutment of the footbridge as located in Summers County, West Virginia. The total proposed abandonment length is 0.12 mile.
